assumes greater importance and the concept of universal Islamic brotherhood is fully comprehended by all Muslims. Malaysia, where Islam plays active role in the national life, could accelerate its commitment to the Ummatic cause through sending volunteers to the battle ground, and by joining UN-peace keeping troops that may be sent to the area to help in resolving the problem. In addition, Malaysia, with its pioneering role in the Third World, is expected to continue to persuade the UN to ensure the implementation of resolutions on the crisis, and to urge all member-states of the OIC to forge a united front to help solve the Islamic issues.
